- President Report (Audra):
 - The raffle license Q2 report was rejected. Judy is working on it and Q3. Only 2 more to do.
- Secretary's Report (Allison/Meredith):
 - Minutes approved and motion passed
- Treasurer's Report (Katherine):
 - Received \$500 from Boulder County, from last year, to put it into the general account
 - Only have September and October numbers. Spent 8k more than we have earned, but not worried because we have not started our fundraising campaign yet.
 - Still have 153k in the bank, which is strong
 - Sales tax forms were filed for Lions Wear
 - Monthly statements need to be reviewed and initialized (completed at the meeting)

Fundraising:

- Volunteering/Fundraising opportunities at Lyons"1st Sundays", 12-4, Nov 3rd and Dec 1, and ongoing
 - Kristen Frances, lead of Lyons Chamber of Commerce, joined us. First Sundays was
 created to highlight our community, and to bring business into slow season. The goal is to
 have visitors see the whole stretch of main street. Last month there was a golf cart tour of
 art. For Nov and Dec, there may be golf cart parking shuttles, take visitors from one end
 of town to the other.
 - This is an opportunity to have a school fundraising community presence, such as the selling wreaths, lions wear etc. Could also charge for golf cart tours, have a table, bake sale, donation bucket on golf cart, talk about capital campaign, etc.
 - Concern from Booster Club with getting enough volunteers. Perhaps we can staff similar
 as we did concessions, sponsor a Sunday, band does December, advertise for the
 wreath, share funds with band and Booster.
 - Need to find golf carts and volunteers. Also, concern with liability, drivers would have to be licensed.
 - Another option is to just have a 'stop' in town. Maybe around Excalibur and Dairy Bar?
 - Follow-up: Judy will reach out to band about December 1.
- Do a spring fundraiser in person, similar to last year. Reach out to those that organized last year.

LionsWear (Leissa/Lori):

- Capital Campaign.
 - Multiple discussions since the last meeting. This year, capital campaign will be a straight ask (no swag). Working on flyer, plus video. Will kick off next week. Everything will go through GoButter. Different options to donate.
 - Incentives this year: The plan is to have an overall fundraising goal for the MS (glow party) and HS (drive in movie party). Goal is 10k per school. If child raises \$250, pie in the face to teacher or admin. Raise \$100, can get a raffle to maybe get into a 'cash grab'.
 - Consider a picture campaign, easier than video.
- Will look into selling donuts
- If drive in movie is a success, we can do it again in conjunction with silent auction inside building in the spring.
